At the UKH, both BA and MA students are required to successfully go through a viva examination as part of their programme requirements.

- **Contribution:** The monograph develops the original conceptual framework of Political Prometheanism, establishing a theoretical bridge between ancient Greek democratic practices and American republican thought. Prometheanism advocates human agency (with emphasis on democratic agency and participation), highlighting at the same time the limits of human reason. The monograph offers a 'Promethean' reinterpretation of the French and American Revolutions, as well as contemporary American Populism, expanding debates in democratic theory. Moreover, it incorporates perspectives on race, gender, and civic inclusion. Political Prometheanism is currently being extended into broader applications within republican theory, political agency/legitimacy, forming the basis of an ongoing research pursued since late 2023. This is a major contribution to Political Theory/Philosophy (republican perspectives), Political History, Theology, and International Relations (particularly Chapter 2).

Milestones:

Short course academic curriculum designing:

On behalf of SiG, and in collaboration with NKUA, I designed the two-week international programme Ancient Perspectives – Modern Challenges (September 2021). I am responsible for: (1) teaching core seminars across all programme cycles; (2) selecting participating instructors; (3) reviewing and selecting student cohorts, with a focus on international representation.

The programme was successfully delivered in 2022, 2023, and 2024, hosting students from Europe, the United States, and the Kurdistan Region of Iraq. Beginning in 2026, the programme is prepared to expand and welcome participants from partner universities in India.

Conference Leadership:

Leveraged my MAP position to organise and coordinate three high-profile conferences in Athens, including ***The Triumph of Liberty, the Loss of Freedom*** (NKUA, 14 April 2022). I served as the main academic coordinator, responsible for content, program schedule, and international outreach.

Project development: Leveraged simultaneous positions in MAP and SiG to design, lead, and implement **the Erbil Project**, an international academic diplomacy initiative, under the auspices of the Greek Consulate in Erbil (Kurdistan Region of Iraq). I convened academics, particularly scholars involved in the Thessaloniki International Media Summer Academy (accommodated in the Aristotle University of Thessaloniki, Greece), high-profile Greek journalists from the Hellenic Broadcast Corporation (ERT TV) and OPEN TV, and community leaders in Erbil, including Christian and Yazidi minority representatives, while exploring possibilities for networking with local universities (UKH). The project culminated in a one-week mission to Erbil (May–June 2022).

- **Project Delivery:** lectures on war and democracy at the Goethe Institute Erbil, the Regional Parliament of Iraqi Kurdistan, and the Kurdish Government's Department of Foreign Relations (DFR).
- **Outcomes & Impact:** (1) Established long-term international academic collaborations, leading to the creation of a joint triple Master's program on Leadership and Ethics (NKUA, UKH, University of Sulaimani); (2) demonstrated international mobility, as the project directly enabled my move to Erbil and my appointment at the UKH; and (3) showcased adaptability by successfully navigating through complex political and cultural in a sensitive environment.

Academic Activities During Non-Contractual Period

- 1) **February 2023 – September 2023:** Immediately following the conclusion of my appointment at Charles University, I received an invitation in January 2023 to join the UKH (in September 2023). For this reason, I did not seek another contractual position, choosing instead to dedicate this period (January–September) to intensive independent research. I completed the first draft of my monograph, *Ancient Greek Democracy and American Republicanism: Prometheus in Political Theory*, in May 2023. I co-organised the *Democracy: Ancient Perspectives, Modern Challenges* summer programme (NKUA), updating course content, refining the teaching plan, and recruiting participants.
- 2) **January 2020 – January 2021:** Focused on completing my PhD thesis (submitted Feb 2021) and preparing publications. Also began collaborating with Study in Greece (SiG), building international academic networks.
