I am a political theorist specialising in leadership, democracy, ethics, and interstate relations, with over eight years of teaching and research experience. My research examines how political authority, civic participation, and moral legitimacy have been understood across Ancient Greek, Byzantine, Islamic, Medieval, and Modern traditions. My recent research has focused on the development of *political Prometheanism* as a framework for understanding leadership, civic participation, and political agency across different intellectual traditions. Alongside my research, I have developed substantial experience in international academic collaboration, curriculum development, and educational diplomacy, setting up partnerships across Europe and the Middle East and contributing to international teaching, consortium-building, and research initiatives.

In particular, professors from UniMC will participate in the Ethical Leadership and Perspectives on Just War volumes, in an attempt to **improve the research visibility, standing, and ranking** of the Dipartimento di Studi Umanistici of the UniMC.

Main Duties: (1) Teaching the following courses: *Theories of International Relations* (MA level), *World History and Modern Political Ideologies* (1st year BA level), *Political Geography, Security and Critical Theory*, and *Key Concepts in Political Thought* (3rd BA level); **(2)** coordinating and facilitating dissertation proposal interviews for post-graduate students, including setting up academic committees for evaluation and outcome determination; **(3) supervising/mentoring:** so far, I have supervised **five undergraduate (4th-year BA) and eight postgraduate (MA) students** in topics related to Iran, liberalism, the Middle East, war ethics, and religious violence. BA students must produce research dissertations of up to **10,000 words**, while MA students complete more extensive theses of up to **22,000 words**; and **(4)** full course curriculum building (January – April 2024): **BA in Philosophy, Politics, and Economics.** Mentoring strategy and activities include: structured supervision meetings (fortnightly) that emphasise student agency and intellectual autonomy. I support students by refining research questions collaboratively, recommending appropriate literature, addressing conceptual and methodological challenges, and encouraging reflective revision rather than prescriptive correction. I also prepare students for final submission and viva examination through dialogic feedback and self-assessment.

Past roles

I have contributed to the development of international academic collaborations linking universities, scholars, and students across Europe and the Middle East. These initiatives emerged from research-related

engagement with scholars working on political thought, democracy, leadership, and intercultural exchange, and gradually developed into broader collaborations involving curriculum design, conference organization, student mobility, and joint academic programmes. To build these collaborations and programmes I had to rely on the following international institutional roles:

(1) Study in Greece (SiG) — Ex Officio Coordinator (Academic Affairs) for Middle East Engagement (April 2021 – September 2024)

(2) The Medici Archive Project (MAP) — Communications Manager (Academic Affairs), Early Modern Greek Culture Programme (September 2021 – September 2022)

Milestones: - Conference Leadership and Scholarly Exchange: In 2022, I co-organised and co-ordinated the three conferences in Athens (1) *The Triumph of Liberty, the Loss of Freedom*, (2) *The Contribution of Byzantine and post-Byzantine scholars in Italy and the origins of the Renaissance*, and (3) *Revisiting the Achievements of Hellenism through time* (cf. *Conferences Section*), bringing together scholars working on democracy, republicanism, and political thought.

- Academic Partnership Development: *The Erbil Project* (December 2021 - February 2023). I leveraged simultaneous positions in MAP and SiG to design, lead, and implement this international academic diplomacy initiative, under the auspices of the Greek Consulate in Erbil (Kurdistan Region of Iraq). I convened academics, particularly scholars involved in the Thessaloniki International Media Summer Academy (accommodated in the Aristotle University of Thessaloniki, Greece), high-profile Greek journalists from the Hellenic Broadcast Corporation (ERT TV) and OPEN TV, academics, and community leaders in Erbil, including Christian and Yazidi minority representatives, while exploring possibilities for networking with local universities (UKH). The project culminated in a one-week mission to Erbil (May – June 2022).

Project Impact: (1) Consortium development: Established long-term international academic collaborations, leading to the creation of a joint triple Master's program on Leadership and Ethics (NKUA, UKH, University of Sulaimani); (2) Expanded opportunities for student mobility, research collaboration, and institutional cooperation across

Europe and the Middle East. For three consecutive years, students from the Kurdistan Region of Iraq were sponsored by the UKH and the AUIS to participate in the international programme *Democracy: Ancient Perspectives – Modern Challenges* (2021); and **(3)** I successfully put the *Democracy: Ancient Perspectives – Modern Challenges* programme into action by building networks with Iraqi universities (and working closely with the Greek Consulate of Erbil). The programme has been delivered successfully since 2022 and has attracted participants from Europe, the United States, and the Kurdistan Region of Iraq.

So far, I have interviewed over 10 international academics, including Professor Neha Kethrapal, and Professor Rasoul Namazi.

- Interviews in the Regional Greek TV Broadcast Network Dion TV, with Dr. Elias Vavouras (once every month, since March 2021) for the Broadcast *Philosophical Debates - Φιλοσοφικοί Διάλογοι* (issues discussed: political philosophy, war and conflicts, religious fundamentalism, and populism).

- Interviews in the Hellenic Broadcast Corporation (ERT) TV (news commentary) and Radio (broadcast: *Hellenes Everywhere*). Topics discussed revolve around geopolitical issues affecting Greece, Caucasus, Europe, the Middle East. Frequency: periodically (usually once every six months, since June 2022). Since January 2026, I **have served as a co-host of the broadcast (remotely)** .

- Interviews and expert commentary on philosophy, democracy, war, and political ethics in Church of Greece Radio 89 (periodically).

- Interviews in the **OPEN** TV Corporation. Topics discussed: Greece and the Middle East, Ukraine, and Russia. Frequency: periodically (usually once every six months since March 2022).

- Periodically authoring for the following international blogs: **Edinburgh University Press** blog, The Conversation, and Open Democracy.
